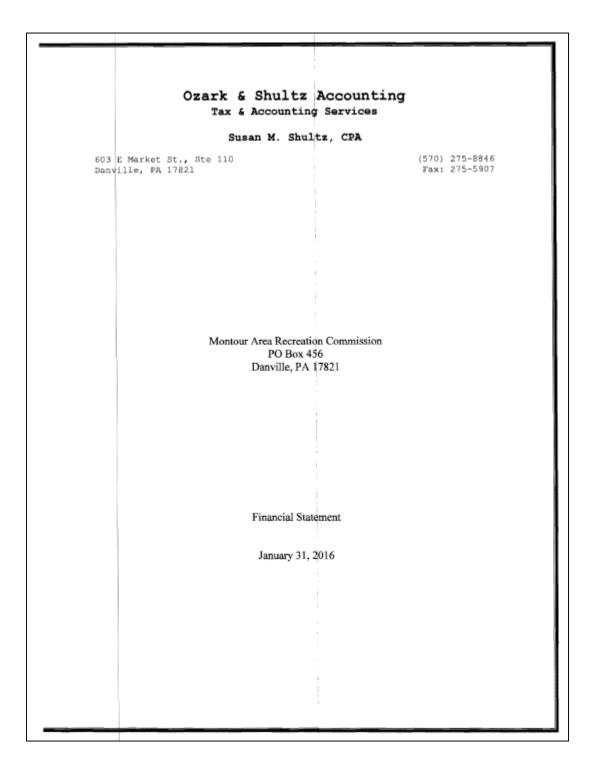

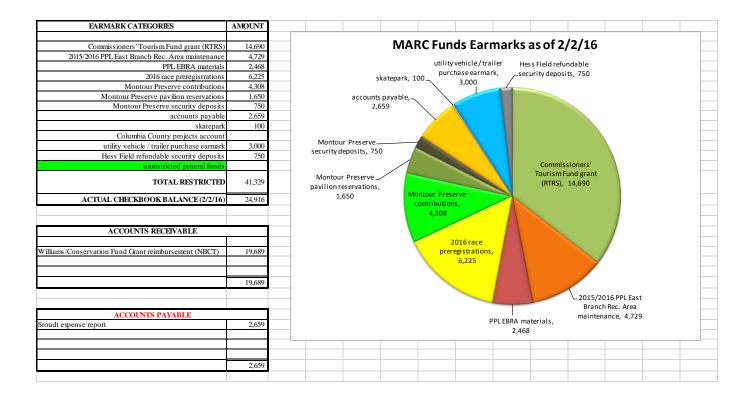

 - Reimbursement decision anticipated by mid-February
 - If approved, funds will be disbursed to SGP, then released to MARC
 - MARC will be allowed to submit two additional requests for reimbursement of up to \$118,811.03 in future North Branch Canal Trail expenses; reimbursement submissions scheduled for 5/31/16 and 10/2/16
 - MARC must incur expenses before requesting reimbursement; MARC's Board will have to determine how best to secure funding to pay expenses until reimbursement is received
- Other
 - Stoudt investigating potential grants from the First Community Foundation Partnership's Centennial Grant (\$40,000) for the Montour Preserve
 - o Stoudt also investigating potential grants from the PPL Foundation for the Montour Preserve

PROJECTS/MANAGED SITES

• East Branch Recreation Area

- \$4,728.84 remains earmarked in our account for site maintenance through April 30, 2016
- \$2,467.78 remains earmarked in our account for supplies
- Talen Energy contacted Stoudt on 1/25/16 to review MARC expenses incurred in 2015 and begin planning for a possible 2016-2017 contract extension
 - Stoudt to follow up with Talen Energy once 2016 mowing costs are known
- River Drive parcel (North Branch Canal Trail trailhead and river access) (no change since last meeting)
 - o Additional site enhancements will be done in coming months as schedule permits

• Hopewell Park / Danville Borough Farm

- Planning for trail directional signage and trail improvements is under consideration for 2016
 - Dave Decoteau/Riverside Adventure Company plan to assist with design and construction of final remaining trail connections
 - Volunteer Kevin Bowie has designed a proposed comprehensive system of signage, including designs for all signs
 - Subject to Danville Borough approval, project is proposed to begin as soon as funding allows, to be completed before the 9/3/16 Hopewell Challenge Mountain Bike races
- Hess Recreation Area (no change since last meeting)
 - Skatepark
 - \$100 remains earmarked in our account for the project, specifically earmarked for reconstruction of the central pyramidal feature
 - Concrete cracks need to be sealed before they become worse
 - Ballfields
 - Softball field needs two loads of infield mix (estimated cost \$1,000); Stoudt expects to order in spring 2016, funding permitting
 - Portions of the field turf will be seeded when weather conditions permit
 - o Road
 - MARC should consider a chip & tar coating of the road to extend its expected useful life; cost estimates will have to be sought when funding allows
 - o Other
 - MARC anticipates heavy use of the site in 2016, including a new football league

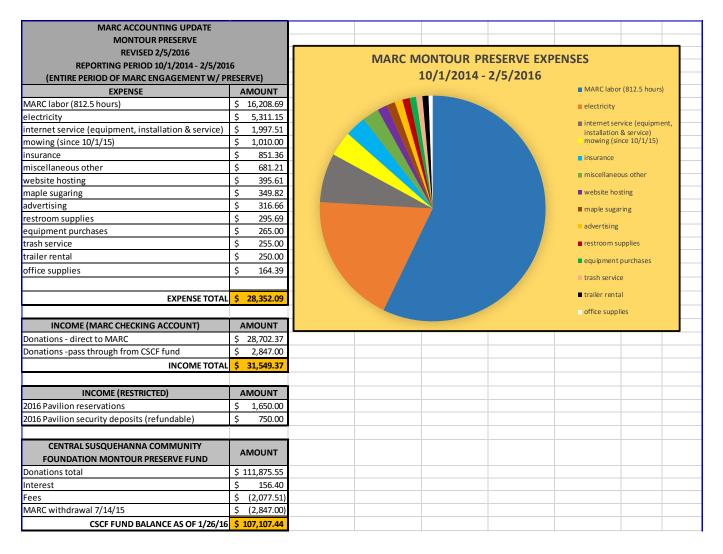
• North Branch Canal Trail

- Stoudt met with the SEDA-COG Joint Rail Authority, North Shore Railroad and Susquehanna Greenway Partnership on 2/1/16 to discuss completed work and consider options for 2016 construction
 - Columbia County land transfer should be done as soon as possible
 - MARC and SGP hope to use the value of the donated land as match for a
 possible DCNR grant to fund Catawissa to Bloomsburg trail design; a 'Waiver of
 Retroactivity' will be needed from DCNR
 - All parties are satisfied with work done to date; no complaints or objections raised
 - MARC will be allowed to work around several large trees in Mahoning Township, so long as all work remains within the property boundaries
 - SEDA-COG Joint Rail Authority will draft a legal agreement allowing MARC's use of the existing track crossing in Montour Township, Columbia County
 - MARC may be required to stabilize the crossing if deemed necessary
 - Stoudt will schedule a meeting with the North Shore Railroad to determine whether the railroad might be able to assist with material transport to the job sites
 - Concerns were raised regarding new campground-related obstructions in the railroad and trail right of way in Cooper Township, Montour County; Stoudt will make contact with the campground owner to try to resolve the issues
- Stoudt met with Brinkash & Associates, DEP, Montour County Conservation District and Columbia County Conservation District on 2/5/16 to consider design options for three remaining stream crossings
 - Two of three locations seem suitable for large culverts with cut and fill from the adjacent towpath
 - One location seems suitable for a wooden bridge, potentially using a pre-existing design from DCNR
 - Stoudt is awaiting a proposal from Brinkash & Associates to perform the necessary engineering and permitting to proceed
- Stoudt anticipates putting trail construction and material purchase out to bid at MARC's May meeting
- Construction of the trail bridge at Break 3 may proceed sooner if existing permitting allows (under review at this time)

PROJECTS/MANAGED SITES (continued)

Montour Preserve

- \$140,577.92 raised to date from at least 279 donors (\$111,875.55 donated to CSCF fund; \$28,702.37 donated directly to MARC)
 - \$156.40 in interest earned to date on CSCF fund
 - \$2,077.51 in account fees deducted from CSCF fund to date
 - \$2,847.00 withdrawn by MARC on 7/14/15 to reimburse expenses incurred to that date
 - \$107,107.44 CSCF fund balance as of 1/26/16
- Visitors' Center/Environmental Education Center security system has been working well since December repairs; no known incidents since that time
- Storage/display cabinets are needed for 200 +/- taxidermy mounts
- One wedding has been scheduled, two are possible
- Planning and setup for maple sugaring has begun
- Ice rescue gear and warning signage has been placed around Lake Chillisquaque



RIVER TOWNS RACE SERIES

- 270 registrations for 3/5 Humdinger Trail Races as of 2/5/16; registration capped at 300
- 23 registrations for 4/2 Montour Preserve Spring Fever Trail Runs; registration capped at 300
- 114 registrations for 5/7 River Towns Half Marathon; registration capped at 500

OTHER NOTES

- All funds have been expended from the \$10,000 Columbia County projects account; Stoudt will meet with Columbia County Commissioners to determine whether they wish to continue the working relationship
 - Public Access Guide to Fishing Creek, Little Fishing Creek and Huntington Creek completed in December; hard copies now available for distribution; will be posted to MARC's website
