WASHINGTONVILLE BOROUGH

Tyler Dombroski reviewed the information from Washingtonville Borough. Tyler also mentioned that the borough was fortunate to receive \$300 from the Youth in Philanthropy (YiP) group through the Danville Area School District.

DANVILLE BOROUGH

There will be no memorial service in Memorial Park due to pandemic circumstances. All summer concerts have been postponed until at least July 4. The Grower's Market has been opened as of this weekend, pending CDC guidelines and social distancing restrictions.

RIVERSIDE BOROUGH

Bill Lavage and Kyle Postupack had nothing new to report.

MONTOUR COUNTY

DANVILLE AREA SCHOOL DISTRICT

Chris Johns reported that tennis courts and stadium have been opened since Montour County has been in a least restrictive phase of the governor's plan. OLD BUSINESS

2020 BUDGET REVISION

Stoudt provided an overview of the 2nd revised proposed MARC 2020 budget. Stoudt noted that the Montour County Hotel Tax anticipated revenues had been further reduced as discussed during the April meeting, as had the anticipated 'other income' line item. Additional cuts had been made to budgeted expenses to reach a balanced budget of \$215,401.00 in expenses and income. This represents \$60,399 in combined cuts or a 21.9% cut. Stoudt recommends the budget be revisited during MARC's August meeting, after the next disbursement of Montour County Hotel Tax revenues.
