TRAIL USERS ARE ENCOURAGED TO REMAIN ALERT TO THEIR SURROUNDINGS AT ALL TIMES  
AND TO WEAR BRIGHTLY-COLORED CLOTHING DURING HUNTING SEASONS

DOGS MUST BE KEPT ON LEASH AND CLOSE AT HAND AT ALL TIMES

TRAIL CLOSURES ARE ENFORCED BY THE MONTOUR AREA RECREATION COMMISSION,  
PA GAME COMMISSION, DANVILLE BOROUGH, AND LOCAL LAW ENFORCEMENT AGENCIES

HUNTING PERMIT WILL BE SUBJECT TO DEFIANT TRESPASSING AND OTHER POSSIBLE CHARGES
