• Montour County Hotel Tax (no updates since last meeting)

- MARC on 2/18/22 received and deposited \$37,530.95 in Montour County Q4 2021 Hotel Tax grant funding
- As of 3/23/22, \$37,538.06 in Montour County Hotel Tax grant funds remain earmarked in MARC's savings account
- Stoudt has provided to McKonly & Asbury MARC's 2021 accounting files to begin MARC's 2021 audit
 - Stoudt on 2/22/22 met with representatives of McKonly & Asbury to discuss MARC's audit in more detail
 - As of 3/23/22, Stoudt does not anticipate any difficulties with the audit being completed by April as planned

• DCNR 2020 Non-Motorized Trails Grant - Danville Borough Levee North Branch Canal Trail Construction (administered by Danville Borough) (no updates since last meeting)

- Danville Borough staff continue working to identify final trail alignments and secure final agreements for affected properties
- o Project construction may begin this year
- o project mapping is available at https://www.google.com/maps/d/edit?mid=17se2PMghOEBzg70bdSTOg3HPCTTO9drE&usp=sharing

• Giant – Healing the Planet Grant (no updates since last meeting)

- MARC on 11/8/21 received and deposited \$10,000 in grant funds to be administered on behalf of Washingtonville Borough
- o Grant funds are to be used to plant new trees at Washingtonville Borough's DeLong Park and to make improvements to the proposed new Mill Park, along Mill Road in Derry Township
- o Grant funds must be expended and work completed by 7/31/22; grant close-out reports must be submitted by 8/31/22
- Per Stoudt's request at MARC's 1/24/22 meeting, Stoudt and Chairman Dombroski have begun investigating the purchase of up to \$2,500 in trees to be planted at DeLong Park in Washingtonville Borough
 - Stoudt hopes to acquire the trees in early April with the intention of beginning planting during the planned 4/9/22 MARC Countywide Park & Trail Cleanup event

• Mahoning Township American Rescue Plan Grant (no updates since last meeting)

- o MARC on 12/13/21 was awarded \$25,000 in American Rescue Act grant funding from Mahoning Township
- o Funds are to be used to offset the negative economic impact of COVID-19 on MARC's operations and to be focused on projects of importance to Mahoning Township residents
- o MARC on 12/30/21 expended \$9,305 to pay Kleinfelder for engineering work for the Hess Loop Trail (J. Manley Robbins Trail) at the Hess Recreation Area
- o \$15,695 remains earmarked in a dedicated checking account to pay a portion of the costs for the planned engineering, permitting, and design work for the Hopewell Park Pump Track



GRANTS (continued)

- DCNR 2021 Park Rehabilitation and Development Grant (Hopewell Park Pump Track)
 - o MARC was notified on 12/30/21 that its application to DCNR for \$125,000 in grant funding to rehabilitate Hopewell Park had been conditionally approved
 - Project activities will include expanding and improving parking, improving site drainage, creating bicycle skills features, reconstructing the existing earthen beginner-level pump track and jumps area, creating a new asphalt-paved pump track, and adding new universally-accessible parking and access features
 - As of 3/23/22, MARC has so far secured \$168,420.73 in pledges and donations to match the DCNR grant
 - o Per action taken during MARC's 1/24/22 meeting, Stoudt on 2/8/22 attended the Montour County Commissioners' meeting to request a redesignation of the grant funds to Montour County
 - MARC's request was approved; the Commissioners on 2/22/22 adopted the resolution required by DCNR to formally consider the grant redesignation
 - All required materials have been submitted to DCNR for consideration
 - DCNR on 2/23/22 acknowledged receipt of the materials and is processing the request
 - Stoudt anticipates receipt of an updated grant agreement and other documentation in coming days and will work with Montour County staff to process the necessary documentation in order to allow work to proceed
 - Stoudt is hopeful engineering and permitting work will be able to begin by early April

MANAGED SITES

• Hopewell Park / Danville Borough Farm

- O Stoudt has worked in recent weeks to clear downed trees and other obstructions from trails as part of the Humdinger Trail Races course marking and clearing
- Stoudt met on 3/2/22 with Danville Borough staff to discuss MARC / Danville Borough storage needs inside the pig barn
 - No changes are anticipated in the short term
- o MARC will work with Eagle Scout candidate Gabe Bittner to create a concrete pad to properly secure the new bike rack recently constructed and donated by Kris Huber and Nick Craven
- Stoudt has updated MARC's mapping of the trail network and has updated MARC's website and created new brochures for printing
 - New trailhead kiosk signs will be installed in April using the updated mapping
- Work is ongoing to prepare for the planned pump track construction and related redevelopment activities as reported elsewhere in this meeting packet

• Montour Township (Columbia County) Legion Road parcel

No concerns noted since last meeting

• River Drive parcel (North Branch Canal Trail trailhead and river access)

- No concerns noted since last meeting
- MARC staff and volunteers will do trimming and dead tree removal at the site in coming weeks as conditions allow

North Branch Canal Trail

- o Montour County and the SEDA-COG Joint Rail Authority have resumed legal action against the owner of the Bear Hunters' Grove Campground to resolve the years-long property ownership dispute
 - Stoudt anticipates legal proceedings will be ongoing through the spring and summer
 - MARC will continue to enforce the trail closure through the disputed lands between trail miles 3.5 4.2; no MARC staff will enter the disputed lands until the matter is resolved
- Stoudt, intern Julian Brehm, and Land Steward Wayne Kashner met on 3/25/22 to review ongoing encroachment concerns along the Columbia County end of the trail and explore options for drainage improvements at several long-term problem areas
 - Stoudt anticipates contacting the Columbia County Conservation District to determine permitting requirements to install a new culvert at trail mile 5.4 (culvert was permitted under NPDES permit, but not installed)
- Land Stewards Wayne Kashner and Jennifer Hunsinger continue to maintain the trail, removing storm damages and performing ongoing litter cleanup
- Stoudt, Wayne Kashner, and Tyler Servose from the Montour County Conservation District met on 3/16/21 to consider options to improve the ford crossing at trail mile 2.72 (no change since last meeting)
 - It is recommended that MARC rebuild the crossing with R6 rock and a log cross-vane to provide better long-term stability for the crossing
 - Stoudt will investigate costs and will schedule the work when funding and staff availability allow
- o Land Steward Wayne Kashner has reported a partially failed culvert at trail mile 1.2
 - Mr. Kashner has made temporary fixes to protect trail user safety, but Stoudt will investigate a more permanent fix (no change since last meeting)



MANAGED SITES (continued)

• Hess Recreation Area

- \circ Stoudt met on 3/21/22 with Elijah Evans to review the section of the Hess Loop Trail (Robbins Trail) between trail miles 1.3 1.5 in need of repair
 - Stoudt and Evans reviewed the findings from the recently completed Kleinfelder engineering report and took measurements as needed to better estimate repair costs
 - Mr. Evans will contact Stoudt again in coming days to discuss cost estimates and possible options for MARC's consideration
 - Stoudt will determine whether MARC has the necessary funding to move forward with the fixes at this time and will likely present information for consideration at MARC's April 25 meeting
 - Stoudt continues to find little change in the condition of the partially collapsed sections of trail
- \circ Stoudt anticipates MARC staff will work during the week of 4/11 4/15/22 to fill potholes along the park access road and parking lot and re-grade trails
- O A portion of the water supply fixture for the men's room sink has cracked and must be replaced
 - Stoudt continues trying to find the necessary replacement parts
- One road culvert pipe remains significantly blocked from repeated storm erosion; Stoudt has reached out to Danville area contacts for assistance (no change since last meeting; work must wait until conditions allow)
- Stoudt continues design work for the new J. Manley Robbins Trail interpretive sign for installation at the Beaver Place Trailhead (no progress since last meeting)
- A section of the Mahoning Flats Trail boardwalk remains out of place because of flooding in late 2021
 - Stoudt hopes to complete the necessary repair during the planned 4/9/22 park and trail cleanup event
- o Stoudt has consulted with R.C. Young, Inc. regarding probable costs to repair the park access road
 - The recommendation is to clean existing potholes and install 9.5mm asphalt repairs, then furnish and install two coats of 1b tar and chip (assuming a road length of 3,600ft and width of 16ft)
 - Total cost is estimated at \$45,000 \$50,000, however cost estimates were secured before the recent dramatic increase in oil and fuel prices
 - Stoudt will continue to seek funding to allow this high-priority project to be completed
- The Hess Recreation Area Field Usage and Maintenance Agreement between MARC and the Danville Lady Railers, with consent by Danville Borough, has expired
 - Stoudt has contacted representatives of the Danville Lady Railers to discuss possible updates to the agreement and expects to have an updated agreement available for consideration in April (no update since last meeting)
- O Stoudt on 2/13/22 met with the 4H Outdoor Explorers group to discuss a project to update the tree identification markers, mapping, and brochure for the Hess Recreation Area
 - Stoudt hopes to complete the project before the start of the 2022/2023 school year



MANAGED SITES (continued)

Montour Preserve

- HVAC units for both the visitors' center and Environmental Education Center auditorium failed on 3/1/22
 - Menco Mechanical visited the site to make the necessary repairs, but had to order replacement parts
 - Repairs were attempted on 3/18/22, after replacement parts were received, but it was found that the compressor on the visitors' center until had also failed and would need to be replaced (part may be under warranty)
 - It was found that a bird had gotten inside the Environmental Education Center auditorium unit and had been struck by the unit's fan
 - The fan motor is not working properly and will likely need to be replaced
 - Menco Mechanical is investigating costs and will contact Stoudt in coming days to discuss options for repair
- o MARC is still waiting for the computer chip necessary to complete the repair of the Visitors' Center / Environmental Education Center security system
 - MARC has been notified the necessary parts are scheduled to arrive 3/30/22 and Stoudt anticipates repairs will begin as soon as Johnson Controls receives the parts
 - The second ½ payment (\$2,745.92) for the repair will now be made on MARC's 2022 budget, rather than in 2021 as originally budgeted
- o MARC successfully conducted the planned 2/26/22 Maple Sugaring Open House, with roughly 700 visitors in attendance
- MARC cancelled the planned 3/13/22 Maple Sugaring Open House because of the weekend's winter storm
- Stoudt and Beam are working to finalize the schedule of special programs for the April June timeframe and expect to release the next quarterly newsletter in coming days
- MARC is working with Eagle Scout candidate Sam Roup to install new fish habitat structures in Lake Chillisquaque, subject to approval by Talen Energy Supply, the PA Fish & Boat Commission, and PA DEP
 - MARC must apply for and receive a DEP GP-1 (Fish Habitat Enhancement Structures) permit before installation may proceed (NO CHANGE SINCE LAST MEETING)
- o MARC is working with Eagle Scout candidate Jay Moyer to create several new picnic tables and rehabilitate several existing tables in need of significant repair
 - Mr. Moyer has completed the first table
 - Stoudt and intern Julian Brehm on 3/24/22 picked up the table and delivered it to Washingtonville Borough's DeLong Park to replace a damaged table which had been removed last fall
- MARC is working with Eagle Scout candidate Logan Maciejewski to repaint the Heron Cove A Pavilion (NO CHANGE SINCE LAST MEETING)
- MARC is working with Girl Scout Gold Award candidate Hailey Exley and possibly with an Eagle Scout candidate to create and install new bluebird boxes, as well as related bluebird habitat restoration work
- o MARC continues to host the 4H Outdoor Explorers group's monthly meetings in the Environmental Education Center auditorium

• Montour Preserve (continued)

- The planned Pennsylvania Master Naturalist spring training program has been cancelled due to too few interested candidates; the program may be rescheduled for this fall or the spring of 2023
- o Right-of-way clearing work for the proposed natural gas pipeline to the Montour Power Plant is nearly complete
 - MARC anticipates work may be completed by the end of the month, weather permitting
 - MARC has performed the necessary cleanup and safety checks along the Goose Woods Trail and Chilisuagi Trail and has reopened both trails to public use
 - A portion of the Wildlife Management Trail has also been reopened to public use, but roughly half the trail will likely remain closed to use indefinitely until pipeline construction is completed
- Stoudt and Beam on 3/17/22 attended a meeting organized by the Middle Susquehanna Riverkeeper Association to discuss possible next steps in securing the funding and support needed for the permanent protection of the Montour Preserve
 - MARC will continue to work with the Middle Susquehanna Riverkeeper Association and other partners to better understand the costs associated with the operation and maintenance of the dam, sewage treatment plant, and other assets

 - MARC is working with the Columbia Montour Visitors Bureau and the Susquehanna River Valley Visitors Bureau to promote bicycling route mapping and online distribution, likely through the RideWithGPS platform (www.RideWithGPS.com)
- o Stoudt anticipates also creating and distributing hard copy brochures of routes within MARC's service area, including those created by the Washingtonville Revitalization Committee
- Stoudt will update mapping for other known routes, including the Chilli Challenge, 75 Miles of MonTour, and others, for publication and promotion

- St. Joseph Catholic School in Danville has donated to MARC the play set formerly in place at the school's playground
- o MARC staff and volunteers, with major support from the Danville Borough Street Department, on 10/30/20 disassembled the play set and moved it to the pig barn for storage
- o MARC staff will repair and possibly repaint play set materials in preparation for reassembly
- o It is anticipated the play set will be reconstructed at the F.Q. Hartman Recreation Area this summer

• Dirty Grin Mountain Biking Festival

- o As approved during MARC's 2/28/22 meeting, MARC has assumed the leadership role in this event, scheduled for 6/10 6/12/22
- Stoudt on 3/8/22 attended (online) the meeting of the Dirty Grin Mountain Biking Festival organizers
- Stoudt continues working to develop a detailed budget for the event
 - Budgeting is not yet complete, but Stoudt remains confident MARC will secure enough sponsorships and other income to offset all expenses

- Surveying work is ongoing for the two parcels along Mill Road in Derry Township (adjacent to Washingtonville Borough) which have recently been acquired through FEMA flood buyouts
 - Discussions are ongoing regarding the potential to develop the parcels into a new 'Mill Park' to include a hand-carry watercraft access to Chillisquaque Creek and limited amenities for passive use of the site
- o Chairman Dombroski continues investigating the purchase of up to \$2,500 in trees to be planted at DeLong Park in Washingtonville Borough
 - It is hoped to acquire the trees in early April with the intention of beginning planting during the planned 4/9/22 MARC Countywide Park & Trail Cleanup event
- Stoudt continues to coordinate with the Washingtonville Revitalization Committee to focus on other projects of interest to the group and Washingtonville Borough
- Stoudt and Dombroski are exploring options for other new stream access locations along Chillisquaque Creek

COOPERATIVE SERVICE AGREEMENT between MONTOUR PRESERVE and

UNITED STATES DEPARTMENT OF AGRICULTURE ANIMAL AND PLANT HEALTH INSPECTION SERVICE (APHIS) WILDLIFE SERVICES (WS)

ARTICLE 1

The purpose of this agreement is to cooperate in a wildlife damage management project as described in the attached Work Plan.

ARTICLE 2

APHIS-WS has statutory authority under the Acts of March 2, 1931, 46 Stat. 1468-69, 7 U.S.C. §§ 8351-8352, as amended, and December 22, 1987, Public Law No. 100-202, § 101(k), 101 Stat. 1329-331, 7 U.S.C. § 8353. , to cooperate with States, local jurisdictions, individuals, public and private agencies, organizations, and institutions while conducting a program of wildlife service's involving mammal and bird species that are reservoirs for zoonotic diseases, or animal species that are injurious and/or a nuisance to, among other things, agriculture, horticulture, forestry, animal husbandry, wildlife, and human health and safety.

ARTICLE 3

APHIS-WS and Montour Preserve agree:

- Montour Preserve will provide payment upon receipt of monthly/quarterly bill to "US Department of Agriculture" in the amount of §4.478.03.
- 2. Nothing in this agreement shall prevent APHIS-WS from entering into separate agreements with any other organization or individual for the purpose of providing wildlife damage management services exclusive of those provided for under this agreement.
- Montour Preserve certifies that APHIS-WS has advised Montour Preserve there may be private sector service providers available to provide wildlife damage management services that Montour Preserve is seeking from APHIS-WS.
- 4. The performance of wildlife damage management actions by APHIS-WS under this agreement is contingent upon a determination by APHIS-WS that such actions are in compliance with the National Environmental Policy Act, Endangered Species Act, and any other applicable federal statutes. APHIS-WS will not make a final decision to conduct requested wildlife damage management actions until it has made the determination of such compliance.
- 5. The cooperating parties agree to coordinate with each other before responding to media requests on work associated with this project.

ARTICLE 4

This agreement is contingent upon the passage by Congress of an appropriation from which expenditures may be legally met and shall not obligate APHIS-WS upon failure of Congress to so appropriate. This agreement also may be reduced or terminated if Congress only provides APHIS-WS funds for a finite period under a Continuing Resolution.

ARTICLE 5

Pursuant to Section 22, Title 41, United States Code, no member of or delegate to Congress shall be admitted to any share or part of this agreement or to any benefit to arise there from.

ARTICLE 6

APHIS-WS assumes no liability for any actions or activities conducted under this agreement except to the extent that recourse or remedies are provided by Congress under the Federal Tort Claims Act (28 USC 1346(b), 2401(b), 2671-2680).

This agreement is not a procurement contract (31 U.S.C. 6303), nor is it considered a grant (31 U.S.C. 6304). In this agreement, APHIS-WS provides goods or services on a cost recovery basis to nonfederal recipients, in accordance with all applicable laws, regulations and policies.

This agreement shall become effective <u>March 20, 2022</u>, and shall continue until <u>September 30, 2022</u>, or when funding expires, whichever is sooner. This agreement may be amended or terminated at any time by mutual agreement of the parties in writing. Further, in the event Montour Preserve does not, for any reason, provide necessary funds, APHIS-WS is relieved of the obligation to provide services under this agreement.

WORK PLAN

Introduction

The U.S. Department of Agriculture (USDA) is authorized to protect American agriculture and other resources from damage associated with wildlife. Wildlife Services activities are conducted in cooperation with other Federal, State and local agencies, private organizations and individuals.

The APHIS WS program uses an Integrated Wildlife Damage Management (IWDM) approach (sometimes referred to as IPM or "Integrated Pest Management") in which a series of methods may be used or recommended to reduce wildlife damage. These methods include the alteration of cultural practices as well as habitat and behavioral modification to prevent damage. However, controlling wildlife damage may require that the offending animal(s) are killed or that the populations of the offending species be reduced.

Wildlife Species: Canada geese.

<u>Description of Damage</u>: An integrated waterfowl damage management program will be implemented to reduce/prevent damages caused by Canada geese that consist of the accumulations of droppings on grounds, athletic fields, parking areas, walkways, and near building entrances; aggressive behavior of geese toward people during the nesting season; and potential health hazards associated with unsanitary conditions.

Services Provided:

The goal of APHIS WS is to manage the damage caused by wildlife by implementing integrated wildlife damage management programs. APHIS WS personnel, who have been professionally trained in wildlife damage management, will assist Montour Preserve in implementing an integrated waterfowl damage management program (IWDM) for Canada geese. An ongoing IWDM program would provide the greatest practical level of protection associated with wildlife damage at this site.

- Montour Preserve will institute a no feeding waterfowl policy and actively enforce (i.e., education and signage) the policy.
- APHIS WS will conduct nest and egg treatment at approximately 7–10-day intervals during the 8week nesting season. Nests and eggs will be collected and disposed of following the 28–30-day incubation period.
- 3. APHIS WS will also remove any goslings found on the property at the request of Montour Preserve.
- 4. APHIS WS will conduct a Canada goose round-up, removing up to 40 of the geese molting on the site. It is possible to remove up to 50% of the molting geese. APHIS WS will document the number



of geese observed on the site prior to molting to accurately determine the number of birds that can be legally removed. Canada geese will be humanely captured, euthanized, and processed for human consumption.

5. APHIS WS personnel will be available to provide technical assistance to Montour Preserve in further deterring Canada geese and preventing other wildlife damage.

The above APHIS WS activities are fully provided for by the Pennsylvania Game Commission, Bureau of Wildlife Protection, Special Use (Depredation/Collecting) Permit and the US Fish and Wildlife Service Depredation permit issued to the Director and/or the WS PA State Director. Activities will be conducted with regular and overtime hours worked as necessary to accomplish the objectives of this program.
