2023 Lawn Care Invitation to Bid

Application Terms and Conditions

Sealed bids for lawn care at the various properties managed by the Montour Area Recreation Commission (MARC) will be received by MARC at any time until 6:59pm on Monday, October 24, 2022. Bids will be publicly opened and read aloud during MARC's regular October 24, 2022 meeting at 7:00pm at the Montour Preserve Environmental Education Center, 374 Preserve Road, Danville, PA 17821 and through the Zoom online meeting platform.

Each bid must be enclosed in a sealed envelope, plainly marked with '**2023 Lawn Care Bid**', and mailed via the U.S. Postal Service to MARC at the address listed above. Sealed bids may also be hand-delivered to MARC on Monday, October 24, between 8:00am and 2:00pm or between 6:30pm – 6:59pm, at the Montour Preserve visitors' center, 374 Preserve Road, Danville, PA 17821.

Bids may be withdrawn by bidders for any reason for a period of forty-eight (48) hours after the time of bid opening. After forty-eight (48) hours from bid opening, bids may not be withdrawn for a period of sixty (60) days.

A certified Treasurer's Check, a Cashier's Check, or a Bid Bond, secured by a Corporate Surety approved by the Commonwealth of Pennsylvania, in the amount of ten (10) percent of the entire bid amount, must accompany the bid. The successful bidder may instead choose to furnish a Performance Bond in the amount of the Contract as awarded as security for the faithful performance of the Contract as awarded as payment of all persons, firms or corporations to whom the Contractor may become legally indebted in performing the work. A corporate surety approved to do business in the Commonwealth of Pennsylvania shall issue said bonds. In lieu of a Performance Bond, MARC will also accept an irrevocable letter of credit or cash escrow in the amount of ten (10) percent of the Contract as awarded.

The successful bidder shall be required to furnish to MARC insurance certificates evidencing General Liability Insurance coverage, Automobile Insurance coverage, and Workers' Compensation Insurance coverage as detailed on page 4 of this packet. Evidence of said insurance coverage shall be required at the time of bid submittal.

Any exceptions to these specifications must be so noted. Bids must be submitted on the official proposal form enclosed with this packet. All line items must be completed and no other marks are to be made thereon. All proposals must be signed. MARC reserves the right to accept or reject any and all bids in part, or in full, and to waive any defect or informalities in the bid procedure in part, or in full, and to award the contract in the best interest of MARC.

GENERAL CONDITIONS

1. The contract term shall extend from April 1, 2023 to November 30, 2023, unless otherwise noted.
2. Mowing services will be provided no more than one (1) time per week at each location unless MARC authorizes a revision to this schedule. MARC reserves the right to reduce the total cuts per season depending on weather or other conditions. Weed control will be provided as needed on the areas defined in the bid sheet document as determined and authorized by MARC.
3. The contractor shall supply all necessary labor, equipment, and materials except as noted in this document. Submitted with bid will be a list of equipment that the contractor will use for this work. This equipment shall be available for inspection at the request of MARC.
4. The contractor shall mow athletic fields at the Hess Recreation Area and all areas at the Montour Preserve only on weekdays between the hours of 7:00am and 4:00pm. Other locations may be mowed on weekdays at other times as needed. Mowing, trimming, weed control, and other lawn care is to be done on Saturdays or Sundays only in unusual situations and only when approved by MARC.
5. Contractor shall remove harmful objects such as glass bottles or other litter from the path of mowing equipment. Contractor is to notify MARC in the event that litter becomes excessive to the point of being outside the normal scope of work.
6. The contractor will trim around all site amenities/ improvements, including but not limited to, fencing, benches, signs, dugouts, planters, paths, and trash receptacles. Mechanical trimmers must not be used to control weeds around tree bases unless special approval is granted by MARC. Weed control sprays shall only be used as specified in this document.
7. Contractor shall be responsible for, and shall restore at his/her expense, all damage to properties caused by the Contractor in the performance of the work which was not reasonably foreseeable as a consequence of the Contractor's performance of this contract.
8. Contractor or subcontractors must be a Pennsylvania Department of Environmental Protection licensed pesticide applicator. Proof of license must be provided at the time of bid submittal. All spraying will be performed in compliance with state regulations.
9. Proof of required insurance coverage as outlined in this bid specification must be submitted to MARC at the time of bid submission.
10. A performance bond or accepted substitute meeting the terms specified in this Invitation to Bid must be submitted to MARC at the time of bid submission.
11. Contractor shall submit three contract names of references with bid.

GENERAL CONDITIONS (continued)

12. All subcontractors needed to complete the specifications of the contract must be listed on the signature page of this bid document. Subcontractors are subject to the same rules and conditions as the primary contractor.
13. Only fully completed bid applications will be accepted. However, bidders may choose to submit a bid for requested Washingtonville Borough line items, but are not obligated to do so. MARC reserves the right to reject any partial applications except as herein noted.
14. Contractor shall invoice MARC monthly for services rendered. Such invoices shall clearly identify the dates of service, location(s) serviced, and the cost per location.
15. All prices must include PA state sales tax and other taxes when applicable.
16. Services for Washingtonville Borough will be reviewed and awarded separately from other line items. This review and award will be at the discretion of Washingtonville Borough Council at a time and place of Washingtonville Borough Council's choosing. Washingtonville Borough reserves the right to accept or reject any and all bids in part, or in full, and to waive any defect or informalities in the bid procedure in part, or in full, and to award the contract in the best interest of Washingtonville Borough.

INSURANCE TERMS AND CONDITIONS

The Contractor (and subcontractors if applicable) shall, at his/her own cost and expense, purchase and maintain in force for the duration of the contract the forms of insurance coverage described hereafter. Subcontractors must produce the same certificates and policies as required of prime contractors, or the prime contractors must submit copies of all policies to which must be attached endorsements indicating that the prime contractor's insurance policy covers the subcontractors to the full extent required by the contracts. Such insurance shall be carried with financially responsible insurance companies, licensed to do business in the Commonwealth of Pennsylvania.

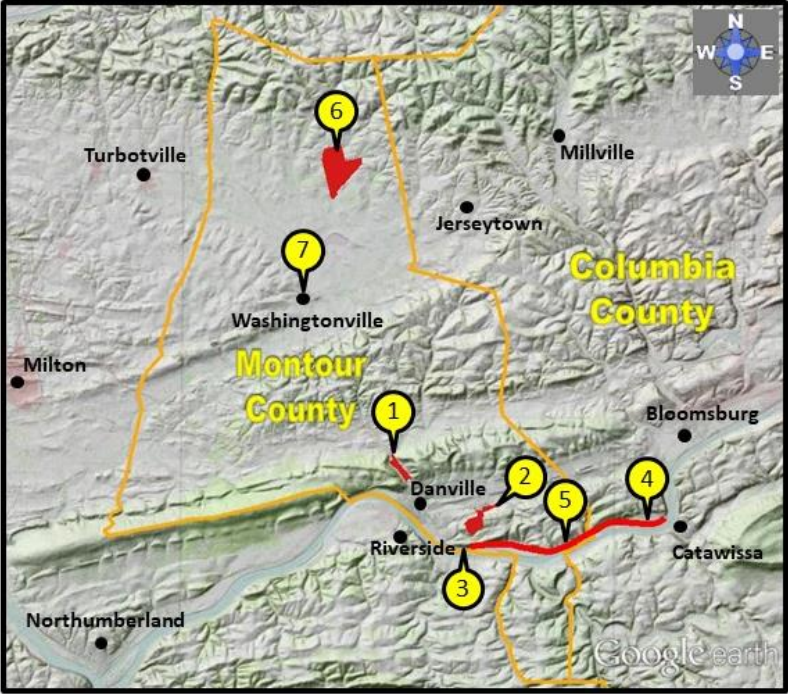
- A. General Liability Insurance – Coverage with a minimum limit of liability per occurrence of one million dollars (\$1,000,000.00) for bodily injury and one hundred thousand (\$100,000.00) for property damage. This insurance shall indicate on the certificate of insurance coverage for Independent Contractors and Subcontractors. The Montour Area Recreation Commission (PO Box 456, Danville, PA 17821) and Talen Energy Supply (Attn: Marc Jackson, 600 Hamilton Street, Suite 600, Allentown, PA 18101) shall be added as Additional Insured Parties. Washingtonville Borough (821 County Line Rd, Turbotville, PA 17772) shall also be added as an Additional Insured Party in the event services are provided for Washingtonville Borough.
- B. Automobile Liability Insurance – Coverage with a minimum limit of liability per occurrence of one million dollars (\$1,000,000.00) for bodily injury and one hundred thousand dollars (\$100,000.00) for property damage.
- C. Workers Compensation Insurance Statutory – Provision of workers' compensation insurance in compliance with the Workmen's Compensation Act of the Commonwealth of Pennsylvania.

Before beginning work, the contractor shall also be required to sign an unconditional waiver of mechanics' and materialmen's liens against Talen Energy Supply (Attn: Marc Jackson, 600 Hamilton Street, Suite 600, Allentown, PA 18101). Waivers shall be filed by MARC in the office of the Prothonotary of Montour County, Pennsylvania.

If, at any time, any of the foregoing policies become unsatisfactory to MARC, as to form or substance, the Contractor shall, upon notice to that effect from MARC, obtain a new policy and submit the same for approval to MARC. Upon failure of the contractor to furnish, deliver and maintain such insurance as provided above, this contract, at the discretion of MARC, may be forthwith declared suspended, discontinued or terminated. Failure of the contractor to take out and/or maintain, or the taking of and or maintenance of any required insurance, shall not relieve the contractor from any liability under this contract, nor shall the insurance requirements be construed to conflict with or otherwise limit the obligations of the contractor concerning indemnification.

2023 LAWN CARE PROPERTIES**

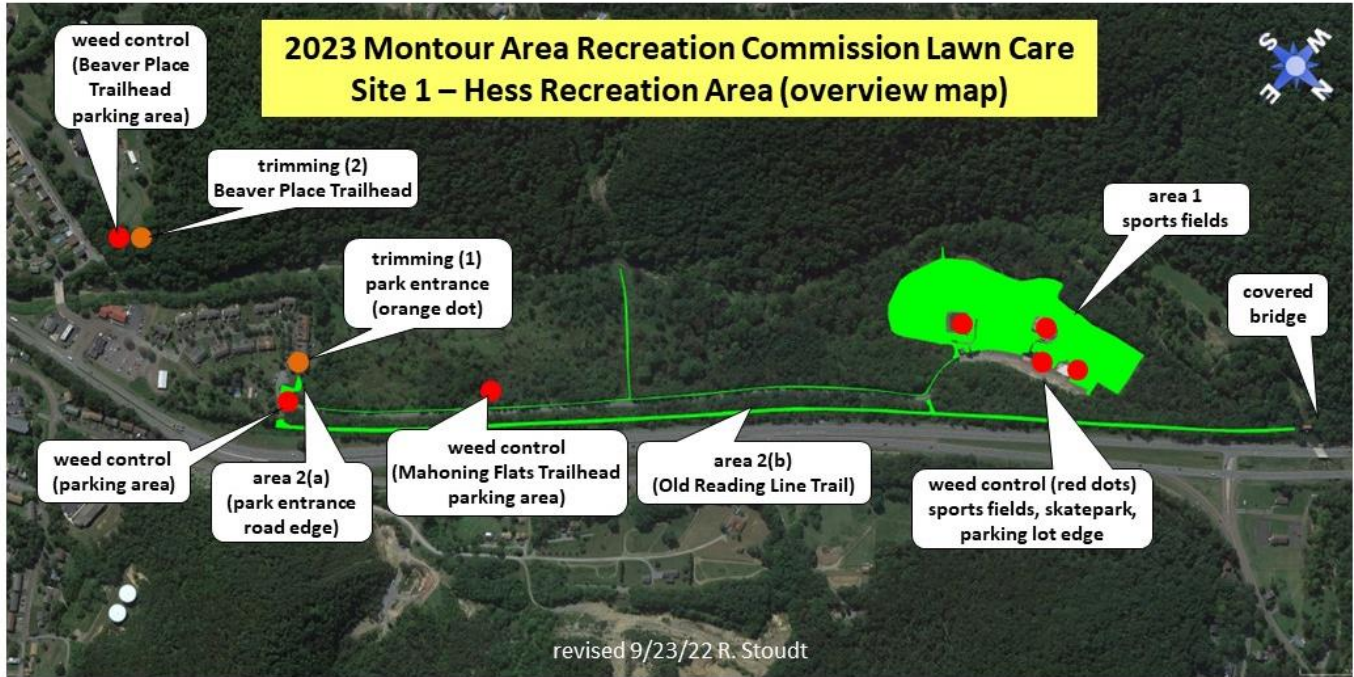
MONTOUR AREA RECREATION COMMISSION 2023 LAWN CARE PROPERTIES

NOTE TO BIDDERS: As of this writing, a portion of this 6.2 mile-long trail, between mile markers 3.5 and 4.0, is partially obstructed. It is anticipated this section of trail will be opened before the 2023 mowing season, but the contractor may have to mow the trail in two sections (3.5 miles and 2.2 miles) from two different access points (1690 River Drive, Danville and 208 Legion Rd, Catawissa).

The average trail width is 60 inches, though some portions of the trail are narrower. **Bidders are strongly cautioned that hazardous conditions exist along this trail, including steep slopes, uneven surfaces, water, and other hazards.** Unless otherwise approved by MARC, the contractor must use not more than a 40 inch-wide walk-behind (not riding) mower for this site.

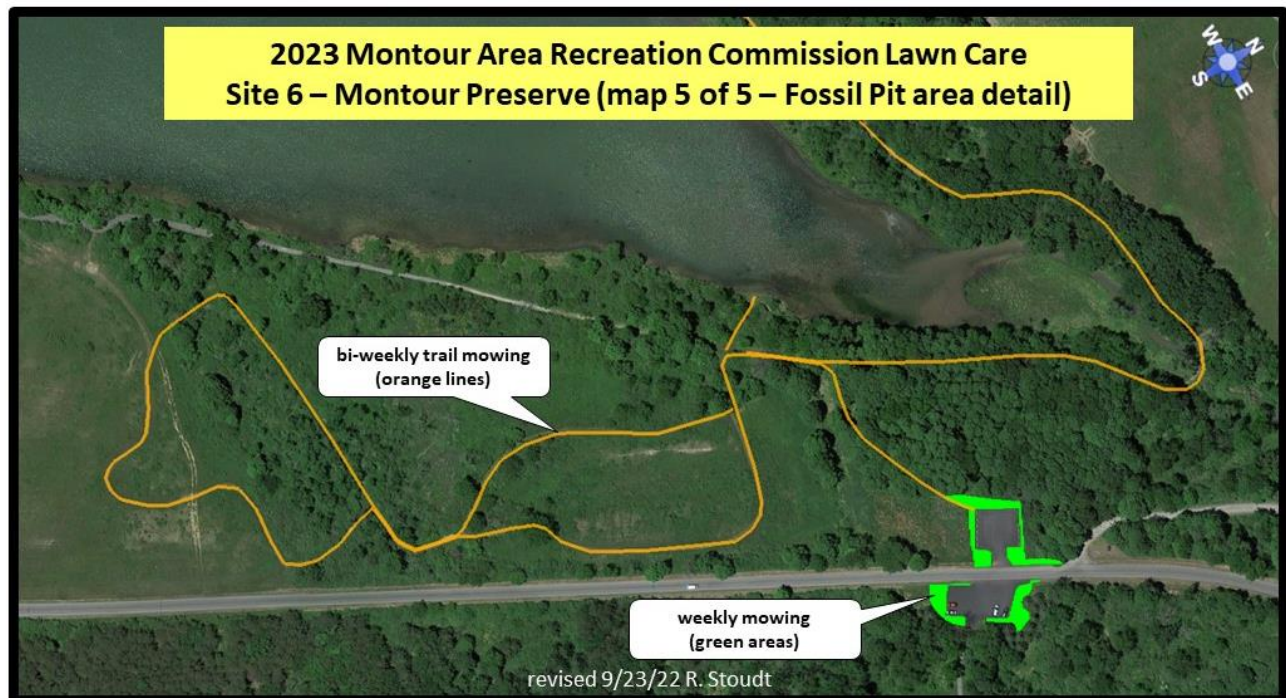

SITE 7E – WASHINGTONVILLE BOROUGH – STREET CURB WEED TREATMENT



We propose to provide weed trimming (weed whacking), weeding, and herbicide treatment as needed along all Washingtonville Borough street curb edges (4,300 linear feet +/-) and streets as shown in the above map. We propose to also weed (by hand, no mechanical trimming or herbicide) street tree grates along the PA-54 roadway. Work scheduling shall be done three times during the season, in coordination with Washingtonville Borough. Washingtonville Borough will encourage residents to remove vehicles from streets on the planned dates of trimming, but bidder should anticipate that some vehicles will remain parked along streets. Trimming, when needed, will not be done within fifty (50) feet of any vehicle left parked along the street. Instead, weeds within fifty (50) feet of parked cars will need to be pulled by hand.

Bidder will be responsible for cleanup and proper disposal of trimmed and pulled weeds; materials are not to be left on streets.

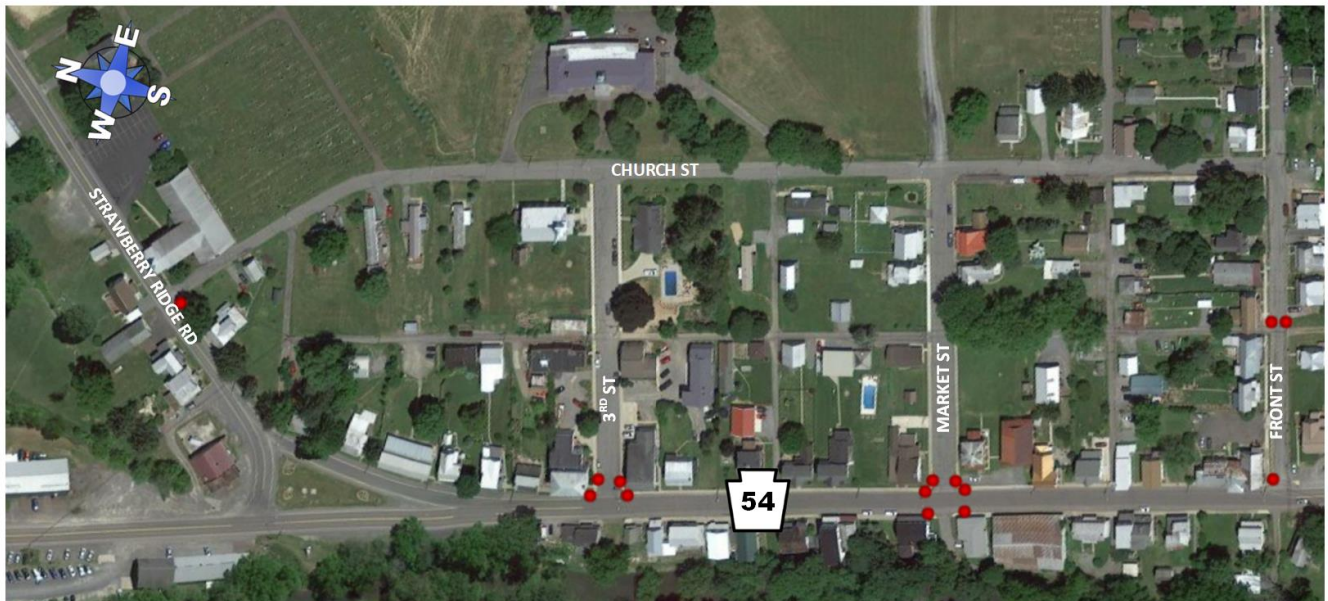
